Post Conversion Update!

Following our core system update on August 1st, members will now see all accounts that are linked to their social security number in online banking. If you'd like to simplify your account dashboard, you can easily "hide" accounts in your settings. Just click on the "Accounts" tab and then click the pencil icon next to the account you'd like to edit. From this area, you have the ability to hide the account, give your account a nickname, or give it a custom color!

2023 Annual Election Nominations

Our 2023 election will be carried out by mail ballot (should there be additional qualified candidates) and will fill two 3-year term positions on the Board of Directors. If necessary, ballots will be mailed to member in January and the election results will be announced at the 2023 Annual Meeting scheduled for Thursday, March 23, 2023.

The nominating Committee has nominated the following candidates for the offices indicated:

Mary Anderson - Currently serving as a Supervisory Committee alternate, Ms. Anderson has flourished in her career as a Certified Public Accountant. Along with serving our credit union, Ms. Anderson takes pride in being involved in the local aviation community and being a 37-year Alaskan resident.

Jack McGary - Presently retired, Mr. McGary served our community for many dedicated years in the field of fire prevention and in the capacity of State Fire Marshall. Mr. McGary has been a member of Northern Skies FCU since 1997 and has been a Northern Skies Board Member since 2005.

Other members interested in becoming candidates can qualify by petition method. Official petition forms must be used and will be available October 17, 2022 by calling the credit union at (907) 561-1407. The signatures and account numbers of at least 1% of members are required in order to qualify as a candidate by the petition method. Petitions must be returned to the credit union by 6p.m. on November 14, 2023. If no additional candidates qualify by petition, the slate of candidates will remain as proposed by the Nominating Committee. If there is only one candidate for each position, there will be no floor nominations.
